Just so you know where I am going with this:

1. I have insisted on more communication between Paul, Denis and I. To date, as evidenced by this email to you, he communicates only when it suits him or is stressed by us.

2. This process of improving two way communication was started by taking over payment for Denis's email and cell phone as we were finding that he was not paying the bills and it would be cut off..then he could not contact us or we could not leave messages for him. So I have explained to him that we operate on constant and effective communication. Things are progressing in that area but it will be another few weeks to get it where I want due to various factors including that our friends have minimal computer skills.

To get the point across I yesterday told both Paul and Denis that I would not deal with invoices and budgets until and unless they are sent to me in encrypted format well enough ahead of time to have them evaluated and processed. Thus there is presently a scramble but I still don't think Denis is getting the message which is why I predict a meltdown in the next few weeks however once we get past that I am confident Denis will get the picture.

4. The picture is that we want constant info and reports from him as to plans, problems, interactions with the DLP caucus and his own staff and voters in his riding. The reports from Paul say that Denis is proactive, aggressive and means well however he seems to not understand that logistics and planning must co-exist with enthusiasm and talent to achieve the goal.

5. Of course this is all part of us being effective in helping Denis and pointing him in the right direction when appropriate. The jury is still out on whether that is possible but a few months of this should tell us. If he can't discipline himself to work with us this way...not a very hard thing to do especially when it is your paid job...then I despair as to how he would achieve anything that he stands for once he is elected. That is one of the reasons I want to see him become proactive now on two fronts. The first is that he should show he can jump on a juicy political issue and run with it e.g. the fuel spill in his riding would be a good one although I have said he can pick his own. Secondly that he stands up for the Charter for Change

and makes it known they are his personal credo and this despite that others in his party might not like it. He claims that might interfere with his getting elected but that is a non sequitur to me. The voters in his riding, if they like him, will elect him and if he has stood up for transparency and integrity I cannot imagine how he thinks that interferes with him getting elected. I would much rather him stand for these things now and then when he gets elected he tells his caucus that he does stand for them and they can deal with him that way. If he does not agree with this then he is, to my way of thinking, setting the stage for getting us to help him get elected and then as soon as he is elected telling us that now that he is in the party's good books he doesn't want to rock the boat. If that is to be his stance why support him?

6. So all in all, and subject to your input and direction, that is where this is going.
